



SKI EQUIPMENT RENTAL CONTRACT

This ski equipment rental contract is entered into between, on one hand, the company ESPORTS CALBÓ, hereinafter referred to as THE LESSOR, and on the other hand, the person or entity listed in this document, hereinafter referred to as THE LESSEE, both of whom acknowledge having the legal capacity to contract and freely bind themselves, and is subject to the following CLAUSES:

1º.- GENERAL CONDITIONS: a) The lessor shall not be obliged to refund money for early return of the equipment by the lessee. b) The lessee is obligated to return the rented equipment to the lessor’s premises within the indicated time frame. Late returns will result in the lessee being charged the daily rental rate for each day of delay. c) The lessee expressly authorizes the lessor to charge, via the credit card previously provided, the value of the rented equipment as specified in this document in case of loss or theft, and also agrees to pay any amount the lessor deems appropriate if the equipment is returned in poor condition. d) If the lessee does not provide a credit card or if the card is inoperative, they expressly agree to pay for lost, stolen, or damaged equipment, authorizing the lessor to deduct the amount from the deposit previously left as a guarantee for the rented equipment. e) Each item is uniquely identified by an alphanumeric code listed in the contract; the returned equipment must have the exact same alphanumeric code, regardless of brand or model. f) The lessor offers an optional insurance for loss, theft, or damage of the rented equipment, covering 70% of the value stipulated in this document.

2º.- CONDITION AND USE OF EQUIPMENT: a) The lessee acknowledges having previously examined the ski equipment provided and confirms it is in good condition and satisfactory. b) The equipment supplied by the lessor is suitable for the lessee’s use, based on the data provided by the lessee, and the ski binding settings have been determined in accordance with the AFNOR FD S 52-748 standard. c) The use of the rented equipment is personal and non-transferable. d) The lessee agrees to use, maintain, and preserve the equipment with diligence and care, in accordance with its intended use. e) It is strictly prohibited for the lessee to modify the binding settings. f) It is strictly prohibited for the lessee to remove the snowboard safety strap.

5º.- LIABILITY: a) The lessee shall be responsible for any damage caused or incurred by third parties resulting from the use of the rented equipment. The lessor is expressly exempt from any liability for damages or injuries that may arise from such use. b) It is the lessee’s responsibility to accurately inform the lessor of their weight, skier profile, and age, in order to determine the correct binding settings.

6º.- JURISDICTION:
For any disputes or issues arising from the interpretation, application, or execution of this contract, both parties formally and expressly submit to the exclusive jurisdiction of the Andorran courts, expressly waiving any other applicable jurisdiction or venue.
